Skilled Migration through RDA Riverina



491

RDA Riverina are contracted to administer the Skilled Work Regional (Provisional) visa (subclass 491) for the Riverina. RDA Sydney holds the contract with Investment NSW. RDA Riverina are subcontracted by RDA Sydney.

- We are provided an allocation of 491s.
- We must follow the process designed by Investment NSW, assessing applicants to their eligibility and referring applicants to Investment NSW.
- Part of our task is to support and welcome new migrants and provide information about the process, and the Riverina.
- We are asked to, and do provide the skills/occupation needs of the Riverina to both RDA Sydney and to Investment NSW.

Skilled Migration through RDA Riverina



494

RDA Riverina are a Regional Certifying Body (RCB) for the Department of Home Affairs for the Skilled Employer Sponsored Regional (Provisional) Visa subclass 494.

- As the RCB, RDA Riverina assists employers to permanently employ overseas skilled workers by assessing the Employer Nomination applications which are submitted to the Department of Home Affairs. We are checking that employers are meeting necessary requirements.
- We are here to assist employers and migrants through the process.

Skilled Migration through RDA Riverina



DAMA

Regional Development Australia (RDA) Riverina have applied along with RDA Orana for a geographical expansion of the Orana DAMA for the Riverina region.

A Designated Area Migration Agreement (DAMA) is a formal agreement between the Australian Government and a regional, state or territory authority.

A DAMA, if approved, will allow some concessions or specific variations to the eligibility requirements for employer sponsored skilled migration. These arrangements allow some flexibility to recruit staff members who may not quite meet the standard visa criteria but are still able to safely perform the functions of the intended role.

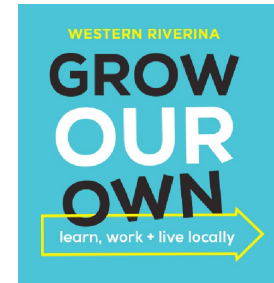
